

**RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT (Hereinafter the “Release Agreement”)**

**AFTER READING THIS ONLINE WAIVER AND COMPLETING YOUR ONLINE REGISTRATION TO PARTICIPATE IN THE ALBERTA WILDLIFESTORIES3DSHOOT, I, AND ANY OTHERS I AM REGISTERING FOR THIS 3D ARCHERY SHOOT, HEREBY WAIVE OR GIVE UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION FOLLOWING AN ACCIDENT**

**PLEASE READ CAREFULLY!**

I, and all other archers I am registering for this shoot, including our heirs and next of kin (referred to hereafter as “we”), acknowledge and agree that:

1. Archery and activities related thereto including transportation, involve inherent risks dangers and hazards, and I freely accept and fully assume all such risks, dangers and hazards and accept the possibility of personal injury, death or property damage or loss resulting therefrom.
2. We hereby release the Sherwood Park Archery Club, their employees, agents, officers, and contractors (the Releasees), from any and all liability for loss, damage or injuries which we may suffer, including any liability arising from negligence of the Releasees, employees, agents, officers, members, volunteers, directors or contractors.
3. We further agree that the Releasees shall not be held responsible for any loss, damage or injury we may suffer while participating in any activity using any facilities or being transported to or from any activities related to shooting for any reason whatsoever.
4. We agree to indemnify and hold harmless the Parties described in paragraph two herein from any and all liabilities or claims made as a result of participation in the activities referred to herein, whether caused by negligence or otherwise.
5. This Release, Waiver, and Indemnity Agreement, is intended to be as broad and inclusive as is permitted within the laws of the Province of Alberta. This Agreement shall be governed and interpreted in accordance with the laws of the Province of Alberta and any action involving the parties to this Agreement shall be brought only within the Province of Alberta. This Release includes a Release including any statutory or other duty of care including any duty of care under the most current version of the Occupiers Liability Act.
6. Any unsportsmanlike conduct or any behavior which may adversely impact the safety of any individual or the range facilities/property may result in the immediate removal of the offender and their entire party from the property.
7. I/WE HAVE READ AND UNDERSTAND THIS AGREEMENT. THIS DOCUMENT MEANS THAT I/WE ARE WAIVING CERTAIN LEGAL RIGHTS INCLUDING THE RIGHT TO SUE WHICH I/WE AND OUR HEIRS, NEXT OF KIN, EXECUTORS, OR REPRESENTATIVES

MAY HAVE AGAINST THE RELEASEES AND THEIR EMPLOYEES, REPRESENTATIVES,  
OFFICERS, AGENTS OR CONTRACTORS.
